## Caselaw – U.S. Supreme Court

- CFPB v. CFSA
  - CFPB funding structure
- Loper Bright Enterprises v. Raimondo
  - Chevron Doctrine
- Corner Post v. Federal Reserve
  - Time period to challenge rules
- SEC v. Jarkesy
  - 7<sup>th</sup> Am. right to jury trial in administrative hearings
- Cantero v. Bank of America
  - Federal preemption of N.A.s







### **Other Caselaw**

- Moore v. Wells Fargo Bank, N.A., 685 S.W.3d 843 (Tex. 2024)
  - Creditor may simultaneously accelerate note and rescind previous acceleration under Tex. Civ. Prac. & Rem. Code § 16.038 and reset limitations period
- In re Texas Dow Employees Credit Union, No. 13-24-00053-CV (Tex. App.—Corpus Christi, March 26, 2024, no pet.)
  - Finance Code §59.006 is the exclusive means of obtaining customer records of a financial institution and trumps TRCP

## Litigation

- Burgess v. FDIC, No. 22-11172 (5<sup>th</sup> Cir.)
  - Presents issues similar to *Jarkesy*
- TBA, IBAT et al. v. OCC, Federal Reserve, FDIC, No. 24-10367 (5<sup>th</sup> Cir. (interlocutory appeal))
  - Challenging CRA final rules
- TBA v. CFPB, No. 23-00144 (S.D. Tex.)
  - Challenging 1071 small business lending rules




## Litigation

- Ryan LLC v. FTC, No. CV-00986-E (N.D. Tex.)
  - Challenges FTC's final rules largely banning non-competes. On August 20, 2024, the rules were set aside pending disposition
- New York v. Citibank, N.A., No. 24-cv-00659-JPO (S.D. NY)
  - NY asserts Citibank liable for wire fraud under EFTA and Reg E where wire initiated through website portal (not exempt under wire exemption)
  - CFPB filed amicus brief in support



#### **Texas Legislature**

- Legislature is in the Interim
- November 5 General Election
- November 11 first day to prefile bill
- January 14 89<sup>th</sup> Legislature convenes





### Texas Legislature: Interim Charges

- Interim Charges
  - Released by Lt. Gov (President of the Senate) and the Speaker of the House in even-numbered years, typically in the Spring
  - Signals priorities for the upcoming session
  - Tasks Legislature with:
    - Overseeing implementation of enacted legislation from previous session
    - Investigating issues of legislative concern, including through committee action



    - Artificial Intelligence
    - Non-Compete Agreements (NEW September 10)
  - Criminal Justice
    - Financial Crimes (NEW September 10)
  - Finance
    - Continue Cutting Property Taxes
  - Local Government
    - Additional Property Tax Relief and Reform
    - Housing Affordability
    - Secure Texas Against "Squatters"
  - State Affairs
    - Protecting Texas Land and Assets








## Texas Legislature: The Interim

    - Foreign-Owned Agricultural Land
  - Business & Industry
    - Housing Affordability
    - Protections Against Fraudulent Deeds
  - Land & Resource Management
    - Housing Affordability
  - Pensions, Investments & Financial Services (PIFS)
    - Environmental, Social, and Governance (ESG)
  - State Affairs
    - Economic Challenges Impacting Insurance Premiums
  - Ways & Means
    - Property Tax Relief
